Qualifications and Experience:

(As per the Order No.MIS-2017/Cr.No.124/2017/Vishi-1, Dated 20 April, 2017, issued by Government of Maharashtra, Higher & Technical Education Department, Mantralaya, Mumbai)

A. Master's Degree with at least 55% marks of any statutory University or its equivalent grade of B in U.G.C. 7 points scale.

B. Relaxation:

- I. The minimum requirement of 55% marks at the Master's Degree level is relaxable up to 5% for the existing incumbents who are already in the University system.
- II. A relaxation of 5% may be provided, from 55% to 50% of the marks at the Master's level for the S.C/S.T. and O.B.C. category candidates.
- II. A relaxation of 5% may be provided, from 55% to 50% of the marks to the Ph.D. Degree holders who have passed their Master's Degree prior to 19th September, 1991.

C. Experience:

I. At least 15 years of experience as Lecturer (Senior Scale)/Lecturer with 8 years experience in Reader's/Associate Professor's grade along with experience in educational administration commensurate with revised pay scale and designation of the UGC.

OR

II. Comparable experience in Research Establishment and/or other Institution of Higher Education.

- III. 15 years of administrative experience, of which 8 years shall be as Deputy Registrar or an equivalent post.
- V. Good knowledge of computer is necessary.
- D. Minimum aggregate experience of 5 years in the examination work of University.
- E. Shall have proven experience of use of technology in education and examination systems.

Tenure:

- Appointment of the Director, Board of Examinations and Evaluation shall be for a term
 of five years or till he attains the age of superannuation, whichever is earlier, and he
 shall be eligible for reappointment for only one more term of five years in the
 University in which he is serving.
- A person appointed as the Director, Board of Examinations and Evaluation from teaching cadre shall retire at the age of 60 years and a person from non-teaching cadre shall retire at the age of 58 years.
- The post carries the retirement benefits as per the Government / University Rules.

- II. Candidate who has obtained a degree as per the Credit System need to provide Certificate of Equivalence in percentage of marks obtained, issued by the Competent Authority.
- III. Certificate/s of teaching/ administrative experience issued by the competent Authority.
- IV. Approval letter/s in case of teachers appointed in affiliated colleges/ recognized institutions.
- V. Appointment orders in case of University Teachers.
- VI. Birth / SSC certificate or other Government document as a proof of date of birth.
- VII. In case of change in name of the candidate, a copy of Government Gazette or any other appropriate certificate.
- 8) Teaching Experience as an approved teacher will only be considered.
