## Qualification & Experience:

Post code: A-1 to A-4

The qualification and experience for the post of 'Dean of Faculty' shall be the qualification and experience of the Professor or Principal in relevant discipline having aggregate minimum teaching or research experience of not less than fifteen years.

### As per post of Professor:

- A i. An eminent scholar having a Ph.D. degree in the concerned/allied/relevant discipline, and published work of high quality, actively engaged in research with evidence of published work with, a minimum of 10 research publications in the peer-reviewed or UGC-listed journals and a total research score of 120 as per the criteria given in Appendix II, Table 2 of UGC Regulation 2018.
  - ii. A minimum of fifteen years of teaching experience in University/College as

Assistant Professor/Associate Professor/Professor, and/or research experience at equivalent level at the University/National Level Institutions with evidence of having successfully guided doctoral candidate.

#### OR

**B** An outstanding professional, having a Ph.D. degree in the relevant/allied/applied disciplines, from any academic institutions (not included in **A** above)/industry, who has made significant contribution to the knowledge in the concerned/allied/relevant discipline, supported by documentary evidence provided he/she has fifteen years' experience.

#### OR

## As per post of Principal:

- C I. Ph.D. Degree;
  - II. Professor/ Associate Professor with a total service/experience of at least fifteen years of teaching/research in Universities, Colleges and other institutions of higher education;
  - III. A minimum of 10 research publications in peer-reviewed or UGC-listed journals; and
  - IV. A minimum of 110 Research Score as per Appendix II, Table 2 of UGC Regulation 2018
- **Note:-** For candidates belonging to specific disciplines, where qualifications other than mentioned above are prescribed by the concerned Apex Body, such prescribed qualifications shall be applicable to those candidates. However, there shall be no change in the requirement of fifteen years of experience as mentioned above.

#### Tenure: Post code: A-1 to A-4

The term of Dean of Faculty shall be co-terminus with the term of office of the Vice-Chancellor or till she/he attains the age of superannuation, whichever is earlier.

# General Terms and Conditions as regards Qualifications:

I. A relaxation of 5% may be provided at the graduate and master's level for the Scheduled Caste/Scheduled Tribe/Differently-abled (Physically and visually differently-abled) categories for the purpose of eligibility and for assessing good academic record during direct

recruitment to teaching positions. The eligibility marks of 55% marks (or an equivalent grade in a point scale wherever grading system is followed) and the relaxation of 5% to the categories mentioned above are permissible, based on only the qualifying marks without including any grace mark procedures.

- II. A relaxation of 5% may be provided, from 55% to 50% of the marks to the Ph.D. degree holders, who have obtained their Master's degree prior to 19<sup>th</sup> September, 1991.
- III. A relevant grade which is regarded as equivalent of 55%, wherever the grading system is followed by recognized University, at the Master's level shall also be considered valid.
- IV. The period of time taken by the candidate to acquire M.Phil. and/or Ph.D. degree shall not be considered as teaching/research experience to be claimed for appointment to the teaching positions.
- V. For the purpose of experience of guiding/guided candidates for research at doctoral level, at least one student must have submitted his/her thesis of Ph.D. for evaluation to the University.
- VI. For the purpose of scrutiny of applications received, provisions of Government of Maharashtra, Higher & Technical Education Department Government Resolution No. Misc-2018/C.R.56/18/UNI-1, dated 08 March, 2019 along with amendments/ clarifications, if any, issued from time to time shall be applicable.

#### **General Terms & Conditions:**

- 1) All above posts are Statutory Posts.
- 2) Candidates belonging to all categories (open and reserved categories) can apply for above post.
- 3) Separate application should be submitted for each post.
- 4) Knowledge of Marathi Language is essential.
- 5) Candidates should apply online from 13.11.2025 to 12.12.2025 on the University website <a href="http://admin.unipune.ac.in/recruitment">http://admin.unipune.ac.in/recruitment</a> and take the printout of the said application.
- 6) As per the Government Resolution No. Sankirn.2025/E.860421/Vishi.1, dated 06.10.2025, issued by the Higher and Technical Education Department, Government of Maharashtra, the said recruitment process will be implemented in accordance with the prescribed procedure.
- 7) In the Process of Selection of Dean of faculty, the Academic, Teachings and Research Credentials (ATR) score shall be considered as per Government Resolution Sankirn.2025/E.860421/Vishi.1, dated 06.10.2025, of Ministry of Higher and Technical Education Department, Government of Maharashtra.
- 8) Applications made through online mode will only be considered by the University. Applications in other forms such as Bio-data, C.V. and any other offline application will not

be considered.

- 9) Application form should be accompanied with self-attested copies of the necessary supporting documents in the following order and candidates should affix a passport size photo on the application:

- 10) Teaching Experience as an approved teacher will only be considered.
- 11) Experience in regular scale will only be considered towards total experience of the candidate.

- 15) If the candidate belongs to the Scheduled Caste/Scheduled Tribe/Exempted Tribe/Nomadic Tribe/Other Backward Classes/Special Backward Classes/ SEBC, he/she should submit a caste certificate certified by the competent authority.
- 16) Candidates claiming to belong to Deprived Castes (A), Nomadic Tribes (B), Nomadic Tribes (C) and Nomadic Tribes (D), Special Backward Classes, Socially and Educationally Backward Classes and Other Backward Classes have to mention in the application do not belong to the advanced and progressive persons/groups of the society and must submit a valid Non-Creamy layer Certificate in the prescribed format issued by the competent authority.

- 18) Candidate from Socially and Educationally Backward Class (SEBC) category shall submit the Caste certificate and Non-creamy Layer Certificate as per the instructions laid down in the Government of Maharashtra Resolution No.BCC-2024/Pra.Kra.75/Arakshan-5, dt.05<sup>th</sup> July, 2024.
- 19) The procedure for filling in the posts reserved for sportsperson shall be as prescribed in the Government of Maharashtra Resolution No.RakriDho-2002/Pra.kra.68/KriYuSe-2, dt.01 st July, 2016 and Government of Maharashtra Resolutions No.Sankirna-1716/Pra.Kra.18/kriYuSe-2, dt.30 th June, 2022.
- 20) Reservation policy for Orphans shall be as prescribed by the Government of Maharashtra Resolution No. Mahiaa-2022/Pra.Kra.122/Ka-03, dt.06 April 2023 will be applicable.

- 21) As per Government circular, Department of Welfare of the Disabled, No. Divyang-2024/Pro.No. 86/D.K.2, dated 27th June, 2024, it is necessary to obtain a Disability Certificate and Universal Identity Card through the Medical Board established from time to time in future as per the Government Decision of the Public Health Department dated 14th September, 2018.
- 22) As per policy for Women's reservation prescribed in the Government of Maharashtra Resolution No. Mahiaa2023/Pra.kra. 122/Karya-2, dated 04 May 2023 will be applicable.
- 23) Provisions regarding submission of non-creamy layer certificate as prescribed from time to time by the Other Backward Classes and Bahujan Welfare Department and the General Administration Department for the concerned Backward Classes, as applicable, shall remain applicable to women desiring to claim for selection to the posts reserved for women belonging to all remaining Backward Classes, excluding Scheduled Castes and Scheduled Tribes.
- 24) Candidates claiming for the posts reserved for women should have to mension in the application that they are residents of Maharashtra and under the non-creamy layer for women belonging to all other remaining backward classes, excluding Scheduled Castes and Scheduled Tribes, if they wish to avail the benefit of women's reservation.
- As per provisions prescribed in the Government of Maharashtra Resolution No. Sankirn-2019/Pra.Kra. 94/19/Vishi-1, dt 11 th April, 2022. The reservation of DT-(A),NT-(B), NT-(C) and NT(D) categories is separate and is internally transferable under the reservation. If a suitable candidate from one of the said categories is not available, the post reserved for that category can be filled in interchangeably, within the categories of DT-(A),NT-(B), NT-(C) and NT(D).
- 26) Regarding parallel reservation, action will be taken as per Government Circular, General Administration Department, No. Sarv-1012/ Pra.kra.16/12/16-A, dated 13th August, 2014 as well as Government Circular, General Administration Department, No. Sarv-1118/ Pra.kra.39/16-A, dated 19th December, 2018 and subsequent orders issued by the Government in this regard from time to time.
- 27) Economically Weaker Section (EWS) candidates As per Government Resolution of, General Administration Department, Kramank. Radhao-4019/ Pra.kra./31/16-A, dated 12 Feb 2019 and dated 31 May, 2021 and subsequent orders issued by the Government in this regard from time to time. Is applicable, wherever the candidates in the said category should have to submit the certificate prescribed by the Government Decision.
- 28) Reservation has been prescribed for socially and educationally backward classes as per Government Resolution, General Administration Department, No. BCC/Pra.kra.75/16-A, dated 27th Feb, 2024 and it will be necessary to submit the caste certificate and non-creamy layer certificate as prescribed under Government Circular, General Administration Department, No. BCC.2024/ Pra.kra.75/Reservation-5, dated 28th June, 2024 and 5 July, 2024.
- 29) The benefit of any kind of reservation is only available to the of Maharashtra. The term

- domicile candidates shall have the same meaning as assigned to it under Section 20 of the Representation of the People of India Act, 1950.
- 30) Candidates claiming any type of reservation (social or parallel) or concessions are required to have a valid certificate in the prescribed format of the relevant law/rule/order as per the advertisement. The validity period of the valid certificate will be considered as per the provisions of the relevant government order (as applicable).
- 31) The Recruitment will be subject to the final decision of the cases filed in various courts regarding social and parallel reservation.
- 32) As per the Notification No.SRV.2000/CR (17/2000) XII dated 28<sup>th</sup> March, 2005 issued by General Administration Department, Mantralaya, Mumbai, candidates shall submit the declaration of the small family in the prescribed Performa attached with Application form as Declaration Form "A"
- 33) Relevant experience, educational qualification and age will be counted as on the last date prescribe for making online application i.e. <u>12.12.2025</u>
- 34) Candidates furnishing incorrect or false information shall stand disqualified at any stage.
- 35) Candidates already employed, shall submit their applications through the proper channel.
- 36) Applications received after the last date of receipt of application, incomplete applications, applications submitted without any of the required documents and applications not submitted through proper channel will not be considered, and no intimation in this regard will be given to the candidates.
- 37) Canvassing directly or indirectly will be a disqualification.
