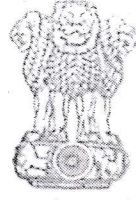

As you are aware, keeping in view the recommendation of Education Commission (1964-66) and objectives of National Policy on Education (1986-92), University Grants Commission, in order to promote autonomy of Institutions in the Country, formulated a scheme of Autonomous Colleges. The Scheme for Autonomy has been in operation for a long time and during this period, large number of Institutions in the country, meeting the quality parameters have benefitted in many ways from such a scheme.
