GUIDELINES FOR INSTALLATION OF ROOF-TOP SOLAR PHOTOVOLTAIC SYSTEM AT SAVITRIBAL PHULE PUNE UNIVERSITY AFFILIATED COLLEGES / INSTITUTES UNDER QUALITY IMPROVEMENT PROGRAM

- 1) The college/Institute must have own building roof /land for installation of rooftop PV system.
- 2) The building shall not house more than one University affiliated college. If so, only one college will be supported financially for installation of Rooftop PV System.
- 3) The college/Institute has to pay Rs. 5000/- (Five thousand) towards the feasibility report, DPR and third party inspection of the project. This payment should be made to 'The Finance and Accounts Officer, Savitribai Phule Pune University' on or before 31st March 2017.
- 4) The suitability of Grid-tied/Hybrid/Off-grid system will be recommended by the technical team of Savitribai Phule Pune University.
- 5) Based on the feasibility report of the technical team of University, the college has to invite quotation only from MNRE Channel Partners for Roof-top Solar PV Program.
- 6) The quotations must include the term that the 'The Supplied System will carry comprehensive maintenance and warranty of 10 years'. The college has to sign a contract in this regard with the shortlisted party.
- 7) The University will provide 50 % advance payment after finalization of quotation by the colleges/institutes and remaining 50 % will be made after installation and third party inspection by the technical team of University.
- 8) The final payment will be made by University only if the roof-top solar PV system are installed at colleges/institutes as per the technical specifications mentioned during the call for proposals and after third party inspection by technical team of University. These technical specifications are provided in Annexure 1.

- ऑफ—ग्रीड सोलर प्रणालीमध्ये बॅटरीची देखभाल व दुरुस्तीची हमी कमीत कमी ३ वर्षे पुरवठादाराने घ्यायची आहे. त्यानंतरची दुरुस्ती व देखभाल महाविद्यालयाने/ संस्थेने स्वख्नचीने करावी.

सौर--ऊर्जा उपकरणाबाबतची विस्तृत तपशीलवार माहिती खालीलप्रमाणे :

सोलर फोटोव्होल्टीक (मी.व्ही.) विद्युत ही एक हरित ऊर्जा आहे आणि या विद्युत ऊर्जा निर्मितीमुळे कार्बन डाय ऑक्साईड किंवा इतर तत्सम अपायकारक वायुंचे उत्सर्जन होत नाही. फाटोव्होल्टीक प्रणाली या मॉडयूल स्वरुपाच्या असून आवश्यकतेनुसार आकारबध्द केली जाऊ शकतात. सद्यस्थितीत महाराष्ट्र राज्यात 'नेट—मिटरींग' कायदा लागू असून छतावरील फोटोव्होल्टीक सिस्टिम मधून तयार होणारी वीज ही ग्रीड इलेक्ट्रिसीटीमध्ये जोडली जाऊ शकते आणि कोणत्याही बॅटरीमध्ये साठवित्याशिवाय आवश्यकतेनुसार ती परत वापरली जाऊ शकते. याशिवाय बॅटरी वापरल्यास या छतावरील फोटोव्होल्टीक सिस्टिम्स या ग्रीड इलेक्ट्रिसीटीशी संबंध न ठेवता Off-Grid System म्हणून सुध्दा वापरल्या जाऊ शकतात.

- १. Grid-Tided फोटो व्होल्टीक प्रणाली

१. Grid-Tided सोलर फोटो व्होल्टीक प्रणाली

या प्रकारच्या फोटो व्होल्टीक प्रणालीमध्ये सोलर पी व्ही पॅनेल्पनी तयार केलेली विद्युत ऊर्जा ही वितरण कंपनीच्या विद्युत ग्रीडशी प्रत्यक्ष जोडलेली असते. आकृतीत टाखविल्याप्रमाणे जोडणी केलेली असते.

या प्रकारच्या प्रणाली कॉलेजमध्ये संस्थेमध्ये स्थापित करण्यासाठी वितरण कंपनीकडून अखंडीत विद्युतपुरवठा असणे आवश्यक आहे. Grid-Tied फोटो व्होल्टीक प्रणाली ही प्रत्यक्ष वितरण कंपनीची विद्युत ऊर्जा उपलब्ध असल्यासच विद्युतऊर्जेची निर्मिती कर शकते. जेव्हा कॉलेजच्या भागामध्ये सतत खंडीत होणारा विद्युत—पुरवठा असेल किंवा Load-shedding असणा—या भागामध्ये कॉलेज असेल तर या प्रकारची फोटो व्होल्टीक प्रणाली स्थापित कर नये.

Grid-Tided सोलर फोटो व्होल्टीक प्रणालीचे फायदे :

अ) नेट मिटरींग मूळे पैशांची बचन : या प्रकारच्या फोटो व्होल्टीक प्रणालीमध्ये तयार झालेली विद्युत ऊर्जा प्रत्यक्ष वितरण प्रीड मध्ये जोडली गेलेली असल्यामुळे बॅटरीमध्ये विद्युत ऊर्जा संचयित करण्याची गरज नाही. त्यामुळे बॅटरी लागत नाही. ज्यामुळे बॅटरीची किंमत व त्यासाठी वारंवार लागणारा दुरुस्तीचा खर्च टाळला जातो. तसेच खर्चिक घटक (उटा. बॅटरी) कमी झाल्यामुळे कमी किंमतीत जास्त क्षमता असलेली फोटो व्होल्टीक प्रणाली ही स्थापित केली जाऊ शकते. ब) वितरण Grid ही आभासी बॅटरी म्हणून काम करते. सोलर फोटा व्होल्टीक विद्युत ऊर्जा ही जेव्हा तयार होते त्याचवेळी ती वापरली किंवा संचयित करावी लागते. त्यामुळे Grid-Tided फोटो व्होल्टीक प्रणालीमध्ये तयार झालेली विद्युत ऊर्जा ही वितरण ग्रीडमध्ये सोडली जाते व कॉलेजला / संस्थेला जेव्हा लागते तेव्हा तो परत वापरली जाऊ शकते. याप्रकारे वितरण ग्रीड ही आभासी बॅटरीग्रमाणे कार्य करते.

यान्यतिरिक्त Grid-Tided सोलर फोटो व्होल्टीक प्रणाली या प्रत्यक्ष वितरण ग्रीडशी जोडला गेलेला असल्यामुळे जर पीव्ही प्रणालीन तयार केलेल्या विद्युत ऊर्जेपेक्षा जास्त विद्युत ऊर्जेचा वापर होत असेल तर जास्तीची विद्युत ऊर्जो ही वितरण ग्रीडकडून घतली जाऊ शकते. तसेच जेव्हा फोटो व्होल्टीक प्रणाली काम करणे बंद करते, वितरण ग्रीडकडून अखंडित विद्युत पुरवठा चालू राहतो.

२. Off-Grid सोलर फोटो व्होल्टीक प्रणाली

ऑफ ग्रीड (ग्रीडपासून वेगळी असलेली स्वयंपूर्ण असलेली) सोलर फोटोव्होल्टीक प्रणाली या जेथे ग्रीड विद्युत पुरवठा उपलब्ध नसलेल्या कॉलेज/संस्थांना नैसर्गिक निकड आहे. ज्या कॉलेज/संस्थांना पक्की—स्थिर, खात्रीलायक ग्रीड विद्युतपुरवठा उपलब्ध आहे अशा ठिकाणी ऑफ—ग्रीड सोलर फोटोव्होल्टीक प्रणाली अस्वीकारणीय आहेत. यासाठी खालील कारणमीमांसा देता येईल.

खात्रीलायक सतत विद्युतपुरवठा असण्यासाठी ऑफ—ग्रीड सोलर फोटोव्होल्टीक प्रणालींमध्ये बॅटरी किंवा तत्सम प्रकारे साठवण करावी लागते. त्याचप्रमाणे बॅटरी किंवा तत्सम विद्युत साठवणूकीची उपकरणे ४—५ वर्षांनंतर बदलावी लागतात. बॅटरी या वापरासाठी क्लीस्ट, महागडया असून सौर—ऊर्जा प्रणालीची एकूणच कार्यक्षमता कमी करतात.

ऑफ-ग्रीड सोलर फोटोव्होल्टीक प्रणालीचे फायदे :

अ) जेथे ग्रीड विद्युतपुरवटा उपलब्ध नाही :

जी ठिकाणे मुख्य किंवा विस्तारीत ग्रीडपासून अलिप्त असतात त्याठिकाणी या प्रकारातील फोटोव्होल्टीक प्रणाली हया वरदान ठरतात.

ब) विद्युतऊर्जा परिपूर्ण होण्यास मदत होते :

विद्युत ग्रीडशी काहीही संबंध न ठेवता आपल्या विद्युत गरजा पूर्ण केल्या जाऊ शकतात. अशा प्रकारे स्वयंपूर्ण संयंत्र असल्याने ग्रीडवरील अवलंबित राहात नाही. यामुळे एकप्रकारे सुरक्षितता येते. तसेच या प्रकारच्या प्रणालीमध्ये बॅटरी लागत असल्याने ज्यावेळी ढगाळ वातावरणामुळे जर फोटोव्होल्टीक पॅनल्सकडून विद्युतनिर्मिती कमी झाली आणि बॅटरोमध्ये साठविलेली विद्युतकर्जा कमी पडत असेल तर डिझेल जनरेटरची सारख्या उपकरणांची सोय उपलब्ध ठेवावी लागते.

ऑफ-ग्रीड सोलर फोटोव्होल्टीक प्रणालीमध्ये लागणारी उपकरणे :

ऑफ-ग्रीड सोलर फोटोव्होल्टीक प्रणालीमध्ये खालील उपकरणे लागतात.

- १. सोलर फोटोव्होल्टीक पॅनल्स
- २. सोलर बॅटरी चार्ज कंट्रोलर
- 3.DC डिस्कनेक्ट स्वीच
- ४. ऑफ-ग्रीड सोलर इन्व्हर्टर
- ५. गरज असल्यास बॅकअप जनरेटर

३. संकरित (Hybrid) सोलर फोटो व्होल्टीक प्रणाली

हायब्रीड सोलर फोटोव्होल्टीक प्रणाली या अगोदरच्या दोन प्रकारच्या प्रणालींच्यानील चांगल्या गोर्ष्टींचा संयोग आहेत. या प्रकारच्या सोलर फोटोव्होल्टीक प्रणाली या १) ग्रीड विद्युत ऊर्जेची जोड असलेली ऑफ—ग्रीड प्रणाली किंवा २) बॅटरीची जोड असलेली ग्रीड—कनेक्टेड सोलर फोटोव्होल्टीक प्रणाली या दोन प्रकारे वर्णन केल्या जाऊ शकतात.

या हायब्रीड प्रणालीमध्ये विद्युत ऊर्जा ही बॅटरीमध्ये साठवण केलेली असते आणि ही साठवलेली विद्युतऊर्जा आपण १. जेव्हा ग्रीडमध्ये विद्युत ऊर्जा उपलब्ध नसताना, २. लोड शेडींगमुळे वीजपुरवठा खंडित असताना वापरली जाऊ शकते. बॅटरीमध्ये साठवलेली विद्युत ऊर्जा ही इन्व्हर्टरला लागणारा संदर्भविभव पुरवते आणि अखंडित विद्युतपुरवठा सुरु राहतो. तसेच जेव्हा सोलर फोटाव्होलिक पॅनल्सकडून वापरापेक्षा जास्त विद्युतनिर्मिती होते, तेव्हा जास्त झालेली विद्युत ऊर्जा ही ग्रीडमध्ये सोडली जाऊ शकते. अशाप्रकारे जी परिस्थती ग्रीड—कनेक्टेड प्रणालीमध्ये असते तशीच परिस्थिती. परंतु सुरिक्षिततेसाठी बॅटरी बॅकअप असलेली प्रणाली कार्यान्वित होते.

संकरित (Hybrid) सोलर फोटोव्होल्टीक प्रणालींचे फायदे :

- अ) संकरित सोलर प्रणाली या ऑफ—ग्रीड सोलर प्रणालीपेक्षा कमी खर्चिक आहेत. कारण बॅटरी ही कमी क्षमतेची लागते. याप्रकारे केवळ जेवढा वेळ लोड—शेडींग किंवा वीजपुरवठा खंडित झाल्यावर केवळ सुरक्षितता जपण्यासाठी लागणारी विद्युत ऊर्जा साठवण करावी लागते.
- ब) बुध्दमान सोलर प्रणाली अश्वासित करतात. जेवढी गरज आहे तेवढयाच ऊर्जेची साठवण करावी लागल्याने खर्च कमी होतो व साठवणीत घट होणारी ऊर्जा व्यय टाळता येतो. तसेच साठवण क्षमतेपेक्षा जास्त ऊर्जा निर्मिती झाल्यास ती ग्रीडमध्ये जोडली जाते.

Proposals Invited for Installation of Rooftop Solar Photovoltaic Systems

Background:

Solar Photovoltaic (PV) electricity is green energy and causes no emission of carbon dioxide or any other gases unlike other conventional method of electricity generation. PV systems are modular in nature and allow sizing as per requirement. Present regulation in the Maharashtra state permits the use of Net-Metering wherein the electricity generated from rooftop PV system can be feed into grid and drawn back as required without battery storage. Additionally if storage batteries are included then the PV systems, it can work like an uninterrupted power supply (UPS). There is also possibility of using PV systems without any interaction with grid, as Off-Grid System.

Types of Systems that can be installed:

- 1) Grid-fied PV system
- 2) Off-Grid System
- 3) Hybrid System

1) Grid-Tied Solar PV Systems

Grid-tied, on-grid, utility-interactive, grid intertie and grid backfeeding are all terms used to describe the same concept – a solar system that is connected to the utility power grid of electricity. A simple schematic below represents the grid-tied PV system.

It is very essential that the grid power is available all the times for grid-tied PV system to function. The grid-ties solar PV system does not provide any power if grid fails. This is not a suitable system if the college has frequent outage of power and load-shedding scenario.

Advantages of Grid-Tied Systems

A) Save more money with net metering

The grid-connection allow to save more money with solar panels through better efficiency rates, not metering, plus lower equipment and installation costs:

Batteries, and other stand-alone equipment, are required for a fully functional off-grid solar system and add to costs as well as maintenance. Grid-tied solar systems are therefore generally cheaper and simpler to install. In other words, you can install higher capacity systems as compared to off-grid PV systems for same cost.

When the solar PV panels will generate more electricity than what is consumed, with net-metering, the college can put this excess electricity onto the utility grid instead of storing it with batteries.

B) The utility grid is a virtual battery

Electricity generated in PV system in grid-tied system has to be consumed in real time. The energy storage typically comes with significant losses.

The electric power grid is in many ways also a battery, without the need for maintenance or replacements, and with much better efficiency rates. But it is very important to have an uninterrupted and reliable grid-supply.

Additional advantages of grid-tied PV system include access to backup power from the utility grid (in case the rooftop solar PV system stops generating electricity for some reason).

Equipment for Grid-Tied Solar Systems

There are a few key differences between the equipment needed for grid-tied, off-grid and hybrid solar systems. Standard grid-tied solar systems rely on the following components:

· Grid-Tie Inverter (GTI) or Micro-Inverters


Import-export meter or Net-Meter

* PV panels, structure, cablines.

2) Off-Grid Solar PV Systems

An off-grid solar system (off-the-grid, standalone) is the obvious alternative where grid is not accessible. For colleges that have access to a stable, reliable grid, off-grid solar systems are out of question. This is because of the following:

To ensure access to electricity at all times, off-grid solar systems require battery storage (if you live off-the-grid). On top of this, a battery bank typically needs to be replaced after 5 years. Batteries are complicated, expensive and decrease overall system efficiency.



Advantages of Off-Grid Solar Systems

A) No access to the utility grid

Off-grid solar systems can be cheaper than extending power lines in certain remote areas.

B) Become energy self-sufficient

Living off the grid and being self-sufficient feels good. Energy self-sufficiency is also a form of security. Power failures on the utility grid do not affect off-grid solar systems.

On the other hand, batteries can only store a certain amount of energy, and during cloudy times, the generation from PV panels and stoage into batteries has to play a better trade-off. Sometimes you may run out of power, and thus, need to install a backup generator to be prepared for these kinds of situations.

Equipment for Off-Grid Solar Systems

Typical off-grid solar systems require the following extra components:


- Solar Charge Controller
- Battery Bank
- DC Disconnect (additional)
- Off-Grid Inverter
- Backup Generator (optional)

3) Hybrid Solar Systems

Hybrid solar systems combine the best from grid-tied and off-grid solar systems. These systems can either be described as off-grid solar with utility backup power, or grid-tied solar with extra battery storage.

This kind of system has a facility of storing energy in batteries, which can be readily used i) when grid fails or ii) during load shedding hours. The electrical energy stored in batteries provide a reference voltage to the inverter as well as supplies the electricity when grid electricity fails. Additionally, when electricity generation from PV system is generating excess power than the

connected load, the excess power can be fed to grid. This is similar situation as that of Grid-Ties System with additional facility for supplying power in the case of unavailability of grid ele.



Advantages of Hybrid Solar Systems

1. Less expensive than off-gird solar systems

Hybrid solar systems are less expensive than off-grid solar systems. The capacity of battery bank can be downsized to minimum size to sustain the times of power outage only.

2. Smart solar holds a lot of promise

You can temporarily store whatever excess electricity of solar panels in batteries and helps an uninterrupted power supply in scene of power outage from grid.

Equipment for Hybrid Solar Systems

Typical hybrid solar systems are based on the following additional components:

- Charge Controller
- Battery Bank
- DC Disconnect (additional)
- Battery-Based Grid-Tie Inverter
- Power Meter.
