ORDER

WHEREAS the University has constituted a Committee under the Chairmanship of Dr. V.B. Gaikwad to recommend fee structure for unaided courses conducted by the University and the affiliated colleges of the University.

AND WHEREAS the Management Council of the University, in its meeting held on 19th September, 2013 has approved the recommendations of the said Committee as regards the fee structure for various courses conducted under the Faculties of Law and Management Sciences, equivalence fees, academic eligibility fees and migration certificate fees, fee structure for Bachelor of Performing Arts, Bachelor of Fashion Designing and Bachelor of Fine Arts Courses and M.Tech (Integrated) and M.Tech (Technology) courses conducted under the Faculty of Technology.

AND WHEREAS the Management Council of the University, in its meeting held on 19th September, 2013 has accorded approval to the fee structure approved by the Vice-Chancellor of the University for LL.M. (One Year) course conducted in the Department of Law of the University.

AND WHEREAS the said fee structure for the courses are required to be made applicable w.e.f. the academic year 2013-14.

AND WHEREAS it will take some time to revise the Ordinance in this respect and submit the same to the Hon'ble Chancellor under Section 54(4) of the Maharashtra Universities Act, 1994.

THEREFORE, I, Dr. Wasudeo N. Gade, Vice-Chancellor of the University of Pune, by and under the powers vested in me under Subsection 8 of Section 14 of the Maharashtra Universities Act, 1994, hereby issue the following directives:

- 1. The fee structure as mentioned in the Appendix shall be made applicable from the academic year 2013-2014 and onwards.
- 2. Other fees prescribed by the University Order No. PGS/542, dated 17/02/2011, Table II shall be applicable for all above mentioned courses.

This Order shall remain in force till the Ordinance in respect of the above mentioned fee structure is framed by the University.
