ORDER

WHEREAS the University has constituted a Committee under the Chairmanship of Dr. V.B. Gaikwad to recommend fee structure for unaided courses conducted by the University and the affiliated colleges of the University.

AND WHEREAS the Management Council of the University, in its meeting held on 17th February, 2016 has approved the recommendations of the said Committee as regards the revised fee structure for Ph.D./M.Phil. under all faculties of the University.

AND WHEREAS the said revised fee structure for the Ph.D./M.Phil. courses is required to be made applicable w.e.f. the academic year 2015-16.

AND WHEREAS it will take some time to revise the Ordinance in this respect and submit the same to the Hon'ble Chancellor under Section 54(4) of the Maharashtra Universities Act, 1994.

THEREFORE, I, Dr. Wasudeo N. Gade, Vice-Chancellor of the Savitribai Phule Pune University, by and under the powers vested in me under Sub-section 8 of Section 14 of the Maharashtra Universities Act, 1994, hereby issue the following directives:

1. The revised fee structure as mentioned in the Appendix A and B shall be made applicable from the academic year 2015-2016 and onwards.
2. Other fees and general conditions prescribed by the University vide Order No. PGS/542, dated 17/02/2011, Table - I & II and Annexure - I shall be applicable to Ph. D./M. Phil courses under all faculties of the University.
3. This order supersedes the Order No. PGS/4804, dated 11/10/2014 issued in this regard.

This Order shall remain in force till the Ordinance in respect of the above mentioned fee structure is framed by the University.
