Respected Madam/Sir,

As per the directives from the Ministry of Personnel, Public Grievances & Pensions regarding reservation policies for temporary/cont appointments vide their Office Memorandum No. 36036/3/2018-Estt (Res.) dated 15.5.2018, reservations for Scheduled Castes (SC), Scheduled Tribes (ST), and Other Backward Classes (OBC) are mandated for all lemporary appointments lasting 45 days or more (copy attached). Further, the DoPT vide its OM No.41034/4/2022-Estt.(Res-I) dated Dated 21 November, 2022 has reiterated the same and requested to ensure that reservation for Scheduled Castes/Scheduled Tribes/Other Backward Classes shall be made in all temporary appointments which are to last for 45 days or more. (copy attached)

National Commission for Backward Classes has also directed the Ministry of Education to comply the above mentioned directives. Subsequently, Ministry of Education has issued a letter to UGC to ensure the reservation policy of Govt. of India as mentioned above in the DOPT OMs. (copy attached)

In the light of these directives, you are requested to ensure that reservation for Scheduled Castes/Scheduled Tribes/Other Backward Classes is made in all temporary appointments which are to last for 45 days or more. Your prompt attention to and implementation of these directives are crucial in fostering an inclusive academic environment.

The above directions may please be brought into the notice of constituent and affiliated colleges of your university for urgent compliance.

It is, therefore, reiterated that, in respect of appointments to Central Government posts and services there shall be reservation for Scheduled Caste/ Scheduled Tribe/ Other Backward Class candidates in temporary appointments which are to last for 45 days or more

Subject:- Reiteration of instructions relating to reservation in temporary appointments - regarding

The undersigned is directed to say that vide OM No. 27/4/67(II)-Estt.(SCT) dated 24.09.1968, reservation for Scheduled Castes and Scheduled Tribes has been provided in all temporary appointments, except the appointments which are to last for less than 45 days. Vide OM No. 36036/3/2018-Estt (Res.) dated 15.5.2018, it has been reiterated that in respect of appointments to Central Government posts and services, there shall be reservation for Scheduled Caste/ Scheduled Tribe/ Other Backward Class candidates in temporary appointments which are to last for 45 days or more.

- 2. The Parliamentary Committee on the Welfare of Scheduled Castes and Scheduled Tribes has, however, observed that the instructions contained in the aforesaid OMs are not followed in letter and spirit and has directed that these instructions may be recirculated to all Government Departments.
- 3. In view of the above, all the Ministries/Departments are requested to ensure that reservation for Scheduled Castes/Scheduled Tribes/Other Backward Classes shall be made in all temporary appointments which are to last for 45 days or more. These instructions should be conveyed to all concerned for strict compliance.
