All the Institutions, Schools, Higher Secondaries or Colleges etc. are informed that National Scholarship Portal 2.0 is operational with effect from 16-08-2020 for online applications of Centrally Sponsored Schemes i.e. Post Matric & Pre Matric Schemes for ST students. Further all the Nodal Officers were informed telephonically to register themselves on NSP. All the students were sent SMS to submit online application forms.

Vide Circular No. DTW/4/PMS/SCHEME/6/CIRCULAR/2020-21/1273 Dated 18-06-2020 & Circular No. DTW/4/PRE-MAT/SCHEME/6/CIRCULAR/2020-21/1487 dated 01-07-2020 all the Nodal Officers of Institutions, Schools, Higher Secondaries or Colleges etc. have been informed about the submission of online applications of ST students to avail benefits under Centrally Sponsored Schemes (Post Matric & Pre Matric Schemes)

However there are some Institutions , Schools, Higher Secondaries or Colleges etc. still have not registered themselves on NSP due to which Scheduled tribe students are unable to apply for same . Hence all the Nodal Officers of Institutions, Schools, Higher Secondaries or Colleges etc. under (Post Matric & Pre Matric Schemes) who have not registered themselves on NSP till date shall register themselves on NSP within a period of 10 days from the receipt of this letter. Also they shall confirm with this office that their Institution profile is functional and to register form is approved by State Nodal Officer i.e. Asst. Director of Tribal Welfare (North).

If any Institution, School, Higher Secondary or College etc fails to submit the application forms of these ST students online then the said Institution, School, Higher Secondary or College etc. will be held responsible for the default.
