This is to inform all eligible candidates that the Department of Law, Savitribai Phule Pune University (SPPU), will be conducting a Spot Admission Round for the Master of Laws (LL.M.) program for the academic year 2026-27. This round is being held to fill the remaining vacant seats.

IMPORTANT DATES AND DETAILS:

1. Date of Spot Round: **21/07/2026**
2. Time: **11.30 am**
3. Venue: Department of Law, Savitribai Phule Pune University, Ganeshkhind, Pune – 411007.

ELIGIBILITY FOR SPOT ROUND: Candidates who have appeared for the SPPU LL.M. Entrance Examination 2026 and meet the minimum eligibility criteria as per the university norms are eligible.

DOCUMENTS REQUIRED (ORIGINALS AND ONE SET OF PHOTOCOPIES):

Candidates must bring the following documents at the time of the spot round:

1. LL.B. Mark Sheets (all semesters/years)
2. LL.B. Degree Certificate (Provisional or Original)
3. SPPU LL.M. Entrance Exam 2025 Scorecard/Hall Ticket
4. Category Certificate (if applicable – SC, ST, OBC, EWS, etc.)
5. Non-Creamy Layer Certificate (for OBC candidates, if applicable)
6. Domicile Certificate
7. Transfer Certificate (T.C.)
8. Migration Certificate (for candidates from universities other than SPPU)
9. Aadhaar Card
10. Passport-sized photographs (2)
11. Other Relevant Documents

ADMISSION PROCEDURE:

- Admissions will be strictly on a first-come, first-served basis among the eligible candidates present at the time of the spot round, based on their merit in the LL.M. Entrance Examination 2026.

- Candidates must be physically present at the venue at the specified time with all the required original documents and their photocopies.
- Incomplete applications or candidates without the necessary documents will not be considered.
- A merit list will be prepared of all the eligible students present on that day against the remaining vacant seats and displayed on the website /notice board.
- Selected candidates will be required to pay the full admission fees. Failure to do so will result in the cancellation of the allotted seat.

NOTE:

- *The number of vacant seats will be displayed at the venue on the day of the spot round.*
- *Participation in the spot round does not guarantee admission.* Admission is subject to the availability of seats and fulfilment of all eligibility criteria.
- *Candidates must report at the venue well before the scheduled reporting time. Late reporting may be treated may be treated as "Not Interested" and the vacant seat may be allotted to the next eligible candidate.*
- *No TA/DA shall be provided for attending the counselling/admission/spot round.*
- *The Department of Law reserves the right to modify, revise or cancel any admission if any of information or document is found to be false, incorrect, incomplete or misleading at any stage.*

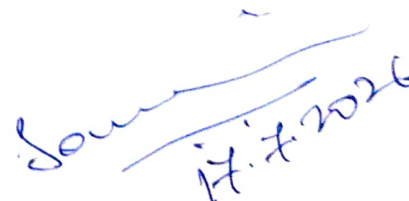
