Rules for Post-Graduate Teacher/M. Phil/Ph. D. Research Guide

1) General Rules:

a) Applicant shall submit his/her online application form within the time frame

notified by the University.

b) Hard copy of the application form shall be submitted to the Academic Section of the University along with the necessary documents duly signed by the Principal of the affiliated college/Head of University Department/Director of the Recognized Institution.

c) Applicant shall be a full-time regular approved teacher working in the Affiliated College/Recognized Institution or a full time regular Research Scientist in Recognized Research Institute of Savitribai Phule Pune University or a fulltime regular teacher working in the University Department/Centre.

2) Rules for Recognition as Post-Graduate Teacher:

a) Five years teaching experience at degree level as an approved teacher.

b) If a teacher is directly appointed as a Post-graduate teacher and has received permanent approval from the University, he need not apply for recognition as a Post-Graduate teacher.

- c) A teacher once recognized as a Post-graduate teacher need not to apply for renewal/ continuation of recognition unless he changes the Affiliated College / Recognized Institution from where he had applied for recognition as a Post-Graduate teacher.
- 3) University Grants Commission, (Minimum Standards and Procedure for Award of M. Phil/Ph.D. Degree), Regulation 2016 and amendments made there in from to time shall apply to M. Phil /Ph.D. Research Guideship.
- 4) Rules for Recognition as M. Phil Research Guide (By Paper/By Research)

a) M. Phil Research Guide by Paper:

(i) Applicant shall be a Ph.D. degree holder in the subject to which he wishes to apply

for recognition.

(ii) Applicant shall be a regular Professor of the University, Institution, College with at least five research publications in refereed journals or a regular Associate/Assistant Professor of the University, Institution, College with Ph.D. degree and at least two research publications in refereed journals.

(iii) In area/disciplines where there is no or only a limited number of refereed journals, the University Authority may relax the condition mentioned in above point No. 4

(a) (ii) with reason to be recorded in writing.

b) M. Phil Research Guide by Research:

(i) Applicant shall be a Ph.D. degree holder in the subject to which he wishes to

apply for recognition.

(ii) Applicant shall be a regular Professor of the University, Institution, College with at least five research publications as corresponding authors in referred journals or a regular Associate/Assistant Professor of the University, Institution, College with a Ph. D. degree and at least two research publications as corresponding authors in referred journals.

5) Rules for Recognition as Ph. D. Research Guide for all faculties:

(a) Applicant shall be a regular Professor of the University, Institution, College with at least five research publications in referred journals or a regular Associate/Assistant Professor of the University, Institution, College with Ph. D. degree and at least two research publications in refereed journals.

(b) In area/disciplines where there is no or only a limited number of refereed journals, the University Authority may relax the condition mentioned in above point No. 5

(a) with reason to be recorded in writing.

(c) An applicant for M. Phil./Ph.D. Research Guideship can make applications for maximum two subjects only (two separate applications); as per the Resolution No. A-07/PA/07/18, dt. 07.06.2018 of the Academic Council held on 07.06.2018

6) Conditions Governing the M. Phil/Ph. D. Research Guideship:

- (i) If an applicant is awarded recognition as a Research Guide, the recognition for the guideship will be continued upto attaining the age of 60 years or till he is a regular teacher in the University Department / Afffiliated College / Recognized Institution / Recognized Research Institute from which he had made an application for the Guideship, which ever is earlier.
- (ii) M. Phil Guideship is co-terminus with the Ph. D. Guideship.

(iii) Applicant shall not be eligible for making fresh application for recognition as a Post Graduate Teacher/M. Phil guide (by papers/research)/Ph. D. guide, if he has attained the age of 60 years at

the time of application.

(iv) It is essential to arrange for a co-guide who shall be approved Research Guide of Savitribai Phule Pune University to guide the already registered research students in case of those M. Phil/Ph.D. Research Guides whose remaining service as a 'Regular Teacher' is less than two years.

(v) No fresh M. Phil/ Ph. D 'Research Students' shall be registered with M.Phil/Ph.D. Research Guides whose remaining service as a 'Regular

Teacher' is less than two years.

(vi) A Research Supervisor/Co-supervisor who is a Professor, at any given point of time, cannot guide more than three (3) M.Phil. and eight (8) Ph.D scholars. An Associate Professor as Research Supervisor can guide up to a maximum of two (2) M.Phil. and six (6) Ph.D scholars and an Assistant Professor as a Research Supervisor can guide up to a maximum of one (1) M.Phil. and four (4) Ph.D. scholars
