

# सावित्रीबाई फुले पुणे विद्यापीठ (पूर्वीचे पुणे विद्यापीठ)

या परिपत्रकाद्वारे सावित्रीबाई फुले पुणे विद्यापीठाशी संलग्नित असलेले सर्व वास्तुशास्त्र महाविद्यालयाचे प्राचार्य यांना विद्यापीठ अधिकार मंडळाने घेतलेल्या निर्णयानुसार कळविण्यात येते की, विज्ञान व तंत्रज्ञान विद्याशाखेतर्गत वास्तुशास्त्र या अभ्यासक्रमासाठी शिक्षक मान्यता देण्यासाठी उमेदवारांचा व्यावसायिक अनुभव ग्राह्य धरणेबाबतच्या निकषास खालीलप्रमाणे मान्यता देण्यात येत आहे.

The period of professional experience shall be counted from the date of registration with the Council of Architecture and the candidate must have valid registration at the time of the interview.

1. During the period of experience claimed as "professional experience" the candidate must not be employed as a teacher in any institute / college/ university on full time (tenure)/ regular (permanent). If so, in such a case the period of employment as a teacher shall be deducted from the total professional experience claimed.
2. If the candidate has pursued any Master's program during the period claimed as professional experience then that duration shall be deducted from the total period of professional experience applied.
3. Architectural Practice has diversified to include [and not to limit to] architecture, interior architecture, urban design, landscape architecture, project management, conservation, and so on. In this scenario establishing a uniform framework for adjudging experience is difficult. However certain minimum documentary evidences shall be produced to establish professional experience and expertise of the candidate.

02	Proprietary or Partnership firm	<ul style="list-style-type: none"> <li>• Registration certificate of the firm indicating date of registration of the firm.</li> <li>• Income tax return filed by the candidate for the years the experience is claimed [the firm and/or individual]</li> <li>• In case of design practice such as architecture / landscape architecture / interior architecture- work orders to be produced. Approval drawings / Working Drawings / reports / photo documentation of the projects completed. In case of architectural work, building completion certificates from the competent authorities / documentary evidence which can substantiate his/her claim regarding the project.</li> <li>• In case of works like project management / green building consultancy / building services consultancy etc. work orders / documentary evidence of the projects in form of reports etc.</li> </ul>
