The Savitribai Phule Pune University, Pune (formerly known as 'University of Pune') is established on 10.2.1949 under the Poona University Act, 1948 and is currently incorporated under the Maharashtra Public Universities Act, 2016. The Jurisdiction of the University extends over three districts i.e. Pune, Nashik and Ahmednagar. The University was recognized under section 2 (f) and 12 (b) of UGC Act, 1956. There are 776 affiliated colleges out of which 27 affiliated Colleges are for girls, 527 P. G. Centres, 30 Autonomous Colleges, 176 Recognized Institutions, 79 Research Institutes and 20 Other Institutes under the jurisdiction of this University and 45 University Departments, 16 University Institutions are on the University Campus imparting higher education, having more than 7 lakh students every year.

His Excellency the Governor of Maharashtra, in his capacity as the Hon'ble Chancellor of this University, has constituted a Search-cum-Selection Committee to recommend names of suitable persons for the consideration of the Chancellor for being appointed as the Vice-Chancellor. The said Search-cum-Selection Committee is hereby inviting nominations/applications from eminent academicians who fulfill the qualifications and experience required for the post of Vice-Chancellor as prescribed under Section 11(3)(f) of the Maharashtra Public Universities Act, 2016 and willing to take on this prestigious assignment. All the necessary details regarding essential qualifications and experience for the post of Vice-Chancellor together with application format and an extract of Section 11 of the Maharashtra Public Universities Act, 2016 are available on the URL <https://vcapp.unipune.ac.in> as well as the website of Savitribai Phule Pune University, Pune (www.unipune.ac.in).

The candidates desirous of applying for the post are required to visit the above URL to acquaint themselves of the essential qualifications and experience for the post, as also the terms and conditions for the appointment to the post of Vice-Chancellor. Only such candidates who fulfil the laid down essential qualification and experience and are willing to accept the assignments, can apply for the post as per the format of the application together with (i) Summary of Details (Annexure-1), (ii) No Objection Certificate (Annexure-2), and (iii) Vigilance Clearance Certificate (Annexure-3) the formats of which are also available on the above URL. The application form along with all requisite documents arranged

Institutions may also nominate suitable candidates. However, all such candidates shall be required to send their CV in the prescribed format so as to reach the Nodal Officer on or before **30.3.2023**.

As this advertisement is issued in supersession of the earlier advertisement dated 12.11.2022, those who had applied against the earlier advertisement dated 12.11.2022 will be required to apply again under this advertisement if they wish to be considered for the post.

Only such of the candidates will be short-listed for interaction with the Search-cum-Selection Committee who will be found to be eligible and suitable for the post of Vice-Chancellor of the University. A list of short-listed candidates would be published on the website of the University in due course. Such short-listed candidates would be required to submit two pages write-up about their suitability for the position, two pages write-up about their vision for the University and names of the three referees along with reference letter. During interaction with the Search-cum-Selection Committee they may be required to make a brief presentation highlighting their achievements and their vision for the University.

The applications received after the prescribed date shall not be considered by the Search-cum-Selection Committee.

Any attempt by an applicant to influence or contact the Chairman or the Member of the Committee shall be treated as a disqualification for the candidate.
