# SAVITRIBAI PHULE PUNE UNIVERSITY CONDITIONS OF AUCTION SALE:

- 1) INSPECTION OF MATERIAL: Inspection of the Scrap Material is on the date of 10.04.2023 from 10.00 a.m. to 03.00 p.m.
- 2) PARTICIPATION FEES: The interested buyers will have to deposit Refundable Participation Fees of Rs. 10,000.00 (Rs. Ten Thousand Only) in the form of Demand Draft in favour of Finance and Accounts Officer, Savitribai Phule Pune University (Payable at Pune). The amount of Rs. 10,000.00 will be refunded after the complete auction is over to the unsuccessful bidders. However, if the intending bidder, from whom the auction money of Rs. 10,000.00 is collected, obstructs/backs out in the preceding the same will be forfeited and lot involved will be re-auctioned immediately or before the end of the auction with the sole discretion of the Auction Committee Cash will not be accepted.

# 3) ACCEPTANCE OF BID

Subject to realization of reserve prices, all sales shall be made to be highest bidder. A person bidding on behalf of another person should produce a written authority from such other person authorizing him to act on behalf of the such other person in all matters at the auction sale, one person can represent himself or on behalf of another person with authorization only. In the absence of such authority the bid, if accepted shall be registered in the name of the actual bidder and he shall be responsible to the Savitribai Phule Pune University, for any loss etc. which might occur to the Savitribai Phule Pune University, as a result of his action without proper authority. In the event of any dispute between bidders, the dispute shall be decided by the authority supervising the sale hereinafter referred to as Supervising Authority and the lot or lots in question reauctioned at his discretion. His decision shall be final and binding on all persons offering bids at the auction. Firms/individuals blacklisted or debarred by the Savitribai Phule Pune University, shall not be allowed to participate in the auction.

4) The auctioneer who is an agent of the Savitribai Phule Pune University, to secure the most advantageous bid for the Savitribai Phule Pune University. Will observe the decision of the Auction committee to refuse or accept the bid of any person without assigning any reason whatsoever. Auctioneer will invariably announce all the conditions governing auction before commencement of the actual sale.

# 5) PAYMENT FOR ACCEPTED BID.

a) Cash/D.D. payment not less than 10% (Ten percent) of the amount of the bid shall be made on fall of the hammer. The auctioneer may, however without assigning any reasons; demand a higher percentage up to 100% amount of the bid immediately after a hammer is knocked down. In doing so he shall, in all cases, act in accordance with directions, if any, given by the concerned Auction Committee.

- b) The sale would be completed on the fall of the hammer and if the bidder concerned fails to forthwith pay the initial amount as explained in (a) above required, the sale shall stand cancelled and lots re-auctioned.
- c) If the buyer fails to make payment of the sale value by the stipulated date or extended date, the bidder shall have to make a payment of penalty at the rate of 18% (Eighteen percent) per annum on the sale value for the entire period of delay up to day and date of Admissible delivery period (i.e. initial 5 working days and for the extension of further 15 days). In the event of failure to complete the payment of sale value of lot purchased by a bidder within the stipulated period (including extension granted, if any) up to a maximum of 15 (Fifteen) days from the date of sale, the sale of such lot shall be cancelled. Initial amount paid shall be forfeited and the lot shall be resold as and when Savitribai Phule Pune University or his representative thinks best without any notice to the bidder.

All taxes, due in respect of the commercial sale under laws in force, shall be payable by the purchaser to the Savitribai Phule Pune University. In addition to the price before taking delivery. The GST and any other taxes as applicable shall be payable by the purchaser before commencing the delivery. The delivery will not be given unless all the payable amount including all the taxes are paid to the Savitribai Phule Pune University.

d) The successful bidder will obtain receipt for part payment from the auctioneer and the receipt for balance amount will be given by the concerned unit on receipt of balance payment. The successful bidder will produce all the receipts in original before taking delivery of the lot.

#### 6) DELIVERY:

Synise Technologies Limited will issue the lot confirmation letter to the winner buyer on the basis of which the buyer will make the payment of the sale amount to the Savitribai Phule Pune University either RTGS or by demand draft and shall obtain the receipt. After making the payment, the buyer shall approach the concerned officer in charge of Estate Department for release of the lot sold to him. The Officer-in-Charge of stores shall then make necessary arrangement for giving the delivery of the goods sold. The goods sold shall be removed by the buyer from the side within the period of 5 (Five) working days, from the date of acceptance of bid. Deliveries will be made only during working hours on all working days on presentation by the buyer to Officer-in-Charge of stores, the copy of sales release order issued. The buyer will make his own arrangement for transport and be will not be entitled to claim any facilities or assistance for transport from the Savitribai Phule Pune University

If the original buyer wishes to take delivery of the stores purchased through his representative, he must authorize his representative by a letter of authority, which shall be presented to the concerned officer in charge of Stores.

The successful bidder or his authorized representative if found indulged in the malpractices while taking delivery of their lot/lots; the amount paid by them or part

thereof will be forfeited by the respective unit head without may notice and delivery of that lot will not be given to them. Decision taken by the unit head will be binding on the concerned bidder. Further, litigations, in such matter will not be binding on Savitribai Phule Pune University.

### 7) NON-DELIVERY:

Where goods are sold on the basis of lot and the buyer fails to obtain delivery of the whole or a portion of the goods sold, he shall not be entitled to make any claim other than for proportionate refund of the value of the undelivered quantity. He shall not be entitled to claim any damage, loss of profit, interest of compensation or on any other account.

# 8) FAILURE TO TAKE DELIVERY AFTER PAYMENT:

The lost paid for must be completely removed at the buyer's expenses within the period specified. If lot is not removed within the time specified, the Savitribai Phule Pune University may re-auction the said lot thereof at purchaser's risk and expenses and while so doing Savitribai Phule Pune University may recover in addition to any loss that loss that may be suffered, a charge on account of storage space at the rate of 1% per day on the original sale price of the said lot or portion there of till the date of resale (inclusive).

Without prejudice to the rights to resale, the Savitribai Phule Pune University at its discretion, will permit the buyer to remove the said lot or portion thereof within an extended period(s) and on payment in advance of a penalty at the rate of 1% percent per day default on the sale price of each lot or portions thereof remaining uncleared until the date of final removal (inclusive.)

#### 9) OTHER CONDITIONS:

- a) Re-sale will not be recognized and sale orders and delivery challans shall be made in the name of the actual buyer only.
- b) The buyer shall be responsible for any damages that may be caused to the premises in taking or removing the lot bought by him. The Savitribai Phule Pune University, may, at its option arrange to make good such damages and the buyer shall be liable to pay the same on demand.
- c) In the event of the auctioneer or the Supervising Authority of Savitribai Phule Pune University being of opinion that bidders are forming ring/cartel and fair prices are not being realized for goods offered in auction, the auctioneer may stop the sale with the consent of the Auction Committee.
- d) The Auctioneer will have to render all types of help to the units of the Savitribai Phule Pune University to settle Sales Tax and Excise cases raised out of sale of auction.
