श्रेणी सुधार (Improvement of Class/Grade) योजनेअंतर्गत विविध पदवी, पदव्युत्तर पदवी/पदविका अभ्यासक्रमांच्या एप्रिल/मे, २०२५ परीक्षेचे आवेदन पत्र/अर्ज ऑफलाईन पध्दतीने भरावयाचे असून अशा परीक्षांचे अर्ज प्रचलित पध्दतीनुसार विद्यापीठाच्या संकेतस्थळावरील पी.डी. एफ. डाऊनलोड करून विद्यापीठ प्रचलित नियमांच्या अधीन राहून योग्य शुल्कासह भरून परीक्षा व मूल्यमापन मंडळ कार्यालयात महाविद्यालयामार्फत जमा करावेत.

उपरोक्त परीक्षांचे आवेदन पत्र/अर्ज हे सुधारित अध्यादेश १६८ मध्ये नमूद केलेले विद्यापीठ नियमांचे काळजीपूर्वक अवलोकन करून व संबंधित विद्यार्थ्यांना/परीक्षार्थींना अवगत करून सर्व संबंधित पात्र विद्यार्थी/परीक्षार्थी यांचेकडून वरीलप्रमाणे ऑफलाईन पध्दतीने भरून घेऊन विहित मुदतीत विद्यापीठाकडे जमा करणे आवश्यक आहे. तसेच सदरबाबत काही बदल झाल्यास ते विद्यापीठाच्या संकेतस्थळावर प्रसिध्द करण्यात येतील, याची कृपया नोंद घेण्यात यावी.

सदर पात्र विद्यार्थ्यांची परीक्षा ही एप्रिल/मे, २०२५ उन्हाळी सत्रातील विद्यापीठ नियमित परीक्षेबरोबर (वेळापत्रक प्रकाशित करण्यात आले आहे) चालू असलेल्या अभ्यासक्रमाच्या पॅटर्ननुसार/समकक्षतेनुसार आयोजित करण्यात येत आहे. सर्व पात्र विद्यार्थ्यांनी आपल्या अभ्यासक्रमातील समकक्ष विषय विचारात घेऊन परीक्षेस प्रवेशित व्हावे.

उपरोक्त परीक्षा अर्ज विनाविलंब शुल्कासहित (Without Late Fee) भरण्याचा कालावधी दिनांक २४/०३/२०२५ ते दिनांक २७/०३/२०२५ पर्यंत आणि विलंब शुल्कासहित (With Late Fee) दिनांक २८/०३/२०२५ ते दिनांक २९/०३/२०२५ पर्यंत आहे. तसेच महाविद्यालयाने सदरचे परीक्षा अर्ज विहित शुल्कासह मा. वित्त व लेखा अधिकारी, सावित्रीबाई फुले पुणे विद्यापीठ, पुणे यांचे नावे देय असलेला धनाकर्ष (Demand Draft) विद्यापीठाच्या वित्त व लेखा विभागात जमा करून त्याची पोहोच घेऊन परीक्षा अर्जासहित दिनांक ०१/०४/२०२५ पर्यंत छाननी व तालिनीकरण कक्ष, परीक्षा विभाग, सावित्रीबाई फुले पुणे विद्यापीठ, पुणे - ४११ ००७ येथे महाविद्यालयामार्फत जमा करावेत.

**ORDER**

WHEREAS Ordinance 168 deals with (3) re-appearance of a candidate for the examination for improvement of his class / grade in Bachelor's degree / Master's degree / Diploma examination;

AND WHEREAS the Board of Examinations and Evaluation in its meeting held on 06.02.2018, vide Resolution No. 05/2018, resolved to permit candidates who passed the final year examination under credit system, maximum two attempts for the improvement of his grade within the period of two years, from the date of passing examination;


AND WHEREAS the Board of Examinations and Evaluation in its meeting held on 30.07.2024, vide Resolution No. 108/2024, has resolved to permit candidates appeared for the final year of Bachelor's degree / Master's degree / Diploma examination held in 2014-15 and thereafter, and whose period of five years from the date of passing the Bachelor's degree / Master's degree / Diploma examination is over, to reappear for such examinations to be held in October 2024 and April, 2025, for improvement of their class / grade, and to amend Ordinance 168 accordingly;

AND WHEREAS it will take some time till the amended Ordinances 168 is approved by the appropriate authorities of the University and the directives of the Hon'ble Chancellor under Section 74(4) of the Maharashtra Public Universities Act, 2016 are received in this regard;

THEREFORE, I, Prof. (Dr.) Suresh W. Gosavi, Vice-Chancellor of the Savitribai Phule Pune University, by and under the powers vested in me under Sub-Section (8) of Section 12 of the Maharashtra Public Universities Act, 2016, hereby issue the following directives:

Amended Ordinance 168 as mentioned in the Annexure shall be made applicable with immediate effect.

AMENDED ORDINANCE 168

IMPROVEMENT OF CLASS /GRADE

1. A Candidate who has passed the Bachelor's degree / Master's degree / Diploma Programs examinations of this University with class mentioned in Column No. I and who desires to improve the class as show in Column No. II below will be permitted at his option to reappear for the same examination without being required to keep any terms.

Column I	Column II
Pass Class or Second Class or Higher Second Class or First Class, as the case may be	Second Class or Higher Second Class or First Class or First Class with Distinction, as the case may be.


2. If a candidate, who has reappeared for the above examination/s under the provision of this Ordinance, fails to improve his class / grade, his performance at such reappearance shall be ignored.
3. A candidate who has passed the Bachelor's degree / Master's degree / Diploma examination in percentage system, will be allowed to reappear for the examination for improvement of class in maximum three attempts, within a period of five years from the date of his passing such examination:
4. A candidate who has passed the Bachelor's degree / Master's degree / Diploma examination in credit system, will be allowed to reappear for the examination for improvement of grade in maximum two attempts, within a period of two years from the date of his passing such examination.
5. Notwithstanding anything contained in Clauses 3 and 4 above, candidates who appeared for the final year of Bachelor's degree / Master's degree / Diploma examination held in the academic year 2014-15 and thereafter, and whose period of five years from the date of passing the Bachelor's degree / Master's degree / Diploma examination is

over. shall be permitted to reappear for such examinations to be held in October 2024 and April, 2025, for improvement of their class / grade.

6. A candidate shall have to reappear for minimum 1/3 and or maximum all the University theory courses at a time on which the class is awarded.
7. A candidate appearing for the improvement of class / grade, shall not be entitled to get benefit of any rules / Ordinance of the University regarding grace marks.
8. A candidate appearing for the improvement of class / grade, shall not be entitled to get any prize / medal / scholarship / award etc.
9. A candidate who desires to apply for improvement of class / grade shall submit his examination application form for improvement of class / grade from the University Department / affiliated College / Recognised Institution from which he has obtained the original degree. The external student shall register his name with External Section of University and submit his examination form through External Section.
10. A candidate who has reappeared for the examination under the provisions of this Ordinance for improvement of his class / grade and improves his class / grade by such re-appearance, shall have to surrender his original degree, statement of marks and passing certificate etc. to the University. The revised degree certificate, statement of marks and passing certificate, to be issued to the candidate, shall bear the remark that he improved his class / grade under this Ordinance.

In any case Examination forms will not be accepted, after the expiry of the last date of the submission of forms, as Notified by the University.
- (6) The concern College/Department/Institution/should collect these forms along with necessary documents and fees and submit the forms separately in the Office/Examination Section with requisite **Demand Draft** (Examination wise) in the name of the **Finance and Accounts Officer, Ganeshkhind, Pune – 411007** within the stipulated time.
- (7) The results of the Class Improvement Scheme will be declared by the Examination Section considering at least performance of 1/3 theory papers now appearing as well as the previous performance of remaining Theory, and all previous performance of Internal, Term-end, Practical, Oral Examination already cleared and passed, for the final Result under this scheme.
- (8) Improved candidates will have to surrender their Degree, Statement of Marks, Passing Certificate in original, after the declaration of their Result of the concern improved class. After surrendering the above documents in original new certificate will be issued in due course of time as in usual process.
