The conference, centered around the theme “**75 Years of the Constitution of India: Realising the Promise of Justice**”, aims to explore the evolution of justice in Indian constitutional democracy and the challenges that remain.

The Seminar Conference aims to bring together over 300 academicians, scholars, students, legal practitioners, and members of judiciary to critically examine the Constitution’s promise of justice and to envision its continued relevance in building a just, inclusive and democratic India.

ESTEEMED SPEAKERS

The Hon’ble Chief Justice of India, Justice Bhushan R. Gavai, and Hon’ble Justice Dr. D.Y. Chandrachud, Former Chief Justice of India, have been invited to grace the conference. The event will also feature participation from distinguished judges, senior advocates, academicians, and legal scholars from across the country.

SUBMISSION GUIDELINES

Abstract Submission

- Participants are invited to submit an **original, unpublished** abstract related to the seminar theme or sub-themes.
- The abstract should be followed by up to 5 keywords
- **Word Limit:** 250–300 words (excluding title and keywords).
- Abstract must be submitted in **MS Word (DOC/DOCX) format**.
- **Font:** Times New Roman, Size 12, 1.5 line spacing, Justified alignment.
- Abstract Must Include: Title of the Paper, Name(s) of Author(s), Designation & Institutional Affiliation, Email ID and Contact Number, City & State of Residence
- Last Date for Abstract Submission: **10th August, 2025**

Notification of Acceptance

- All submitted abstracts will be reviewed by a panel of subject experts.
- Notification of acceptance will be sent via email by **15th August 2025**.
- Only selected abstracts will be eligible for full paper submission.
- Once Abstract is accepted, the author(s) are required to make the payment. Screenshot of proof of payment is to be mandatorily submitted during full paper submission.

Registration Details

- Registration is mandatory only after acceptance of the abstract.
- **Amount:**
 - **Students** (individuals currently enrolled in undergraduate, postgraduate programmes in law or allied fields): **₹300/-**
 - **Academicians / Professionals** (includes researchers, advocates, judges, policy professionals, and independent scholars): **₹700/-**
- Co-authored papers (maximum two authors) are not required to pay separately. A single registration covers both authors.
- Details of payment mode will be shared in the acceptance email or via an official notification.
- A screenshot or receipt of the payment must be attached with the full paper submission.



Full Paper Submission

- Authors of accepted abstracts must submit their full research papers by **30th August, 2025** along with proof of payment of registration/processing fee.
- **Word Limit:** 3,500 to 6,000 words (excluding footnotes and references).
- **Citation Style:** Bluebook 20th ed.
- **Originality Requirement:** Plagiarism of more than **10%** will lead to rejection.
- **Font & Formatting:** Times New Roman, Size 12 (main text), Size 10 (footnotes), 1.5 line spacing, A4 size, 1-inch margins.
- **Submission must include:** Final Draft/Document and Proof of Payment of Registration fee.

Paper Presentation at Conference

- After submission of full papers by 30th August 2025, each paper will be evaluated by an expert panel.
- Only selected papers will be invited for **Presentation** during the Two-Day National Seminar on 13th & 14th September 2025 at the Savitribai Phule Pune University.
- The selection will be based on originality and relevance of the paper, academic rigour and alignment with the seminar theme
- Notification of selection for presentation along with further instructions will be sent by **5th September 2025** via email.

Publication Opportunity

- Selected papers will be published in a peer-reviewed edited book with an ISBN code by Department of Law, Savitribai Phule Pune University.
- Authors of published papers will receive a Certificate of Publication.
- Selection for publication is independent of presentation. Papers not presented may still be published if they meet editorial standards.
- The editorial board reserves the right to accept, reject, or suggest modifications to papers.
