**Notification for Assistant Professor (Contractual)**

Applications are invited in the following proforma for **One (01) Posts of Assistant Professor (Contractual for OBC CATEGORY ONLY)** in the Department of Law for the academic year 2020-21.

**Number of Post : 01 (OBC CATEGORY ONLY)**

**Tenure of Appointment:** Purely temporary for a period of one academic year.

**Salary:** Rs. 30,000/- per month (consolidated)

**(Non-Creamy Layer Certificate is applicable to reserved categories except SC & ST)**

Note : For the above posts the eligibility criteria will be as follows:

**(I) General/Minimum Qualifications for the post of Assistant Professor(Contractual) to be filled as per UGC Norms & Govt.of Maharashtra Resolution No. Misc-2018/C.R.56/18/UNI-1. dated 08.03.2019.**

Eligibility (A or B) :

A:

- 1) A Master's degree (LL.M.) with 55% marks (or an equivalent grade in a point –scale wherever the grading system is followed) in a concerned/relevant/allied subject from an Indian University, or an equivalent degree from an accredited foreign university.
- 2) Besides fulfilling the above qualifications, the candidate must have cleared the National Eligibility Test (NET) conducted by the UGC or a similar test accredited by the UGC, like SET or who are or have been awarded a Ph.D. Degree in accordance with the University Grants Commission (Minimum Standards and Procedure for Award of M.Phil/Ph.D. Degree) Regulation, 2009 or 2016 and their amendments from time to time as the case may be exempted from NET/SET.

*Provided* that candidates who have been awarded a Ph.d Degree in accordance with the University Grants Commission (Minimum Standards and Procedure for the Award of M.Phil/Ph.d Degree) Regulation 2009, or the University Grants Commission (Minimum Standards and



Procedure for the Award of M.Phil/Ph.D. Degree) Regulation, 2016, and their subsequent amendments from time to time as the case may be shall be exempted from the requirement of NET/SET for recruitment and appointment of Assistant Professor or equivalent positions – in Universities/Colleges/Institution.

*Provided* the candidates registered for the Ph.d. programme prior to July 11, 2009, shall be governed by the provisions of the then existing Ordinances/Bye-laws/Regulations of the Institution awarding the degree and such Ph.D. candidates shall be exempted from the requirement of NET/SET for recruitment and appointment of Assistant Professor or equivalent positions in Universities/Colleges/Institutions subject to the fulfillment of the following conditions:

- a. The Ph.D. degree of the candidate has been awarded in regular mode only;
- b. The Ph.D. thesis has been evaluated by at least two external examiners;
- c. An open Ph.D. viva voce of the candidate has been conducted;
- d. The candidate has published two research papers from his /her Ph.D. work, out of which at least one is in a referred journal; and
- e. The candidate has presented at least two papers, based on his/her Ph.D. work in conferences/seminars, sponsored/funded/supported by the UGC/ICSSR/CSIR or any similar agency.

*Note: The fulfillment of these conditions is to be certified by the Registrar or the Dean (Academic affairs) of the University concerned.*

- 1) NET/SET shall also not be required for such Masters Programmes in disciplines for which NET/SET is not conducted. However, Ph.D. degree shall remain the minimum eligibility for appointment of Assistant Professor in such disciplines.

The Ph.D. degree has been obtained from a foreign university institution with ranking among top 500 in the World University Ranking (at any time) by any one of the following:

- i) Quacquarelli Symonds (QS)
- ii) The Times Higher Education (THE) or
- iii) The Academic Ranking of World Universities (ARWU) of the Shaghai Jiao Tong University (Shanghai)





(III) **General Terms and conditions as regards qualifications as per UGC Norms & Govt. of Maharashtra Resolution No. Misc-2018/C.R.56/18/UNI-1 dated 08.03.2019.**

- (1) The minimum qualification required for the post of Assistant Professor shall be as specified by the UGC in its regulations and accepted by State Government time to time.
- (2) A minimum of 55% marks (or an equivalent grade in a point-scale, wherever the grading system is followed) at the Master's level shall be the essential qualification for direct recruitment of teachers and other equivalent cadres at any level.

I A relaxation of 5% shall be allowed at the Bachelor's as well as at the Master's level for the candidates belonging to Scheduled Cast/Scheduled Tribe/Other Backward Classes (OBC) (Non –creamy)/Differently – abled (a) Blindness and low vision; (b) Deaf and Hard of Hearing; (c) Locomotors disability including cerebral palsy, leprosy cured, dwarfism, acid – attack victims and muscular dystrophy; (d) Autism intellectual disability, specific learning disability and mental illness; (e) Multiple disabilities from amongst persons under (a) to (d) including deaf-blindness) for the purpose of eligibility and assessing good academic record for direct recruitment . The eligibility marks of 55% marks (or an equivalent grade in a point scale wherever the grading system is followed) and the relaxation of 5% to the categories mentioned above are permissible, based only on the qualifying marks without including any grace mark procedure.

- (3) A relaxation of 5% shall be provided (from 55% to 50% of the marks) to the Ph.D. Degree holders, who have obtained their Master's Degree prior to 19 September, 1991.
- (4) A relevant grade which is regarded as equivalent of 55% wherever the grading system is followed by a recognized university, at the Master's level shall also be considered valid.
- (5) The time taken by candidates to acquire M.Phil and / or Ph.D. Degree shall not be considered as teaching /research experience to be claimed for appointment to the teaching positions.
- (6) The time taken by candidates to acquire M.Phil and / or Ph.D. Degree shall not be considered as teaching/research experience to be claimed for appointment to the teaching positions. Regular faculty members up to twenty per cent of the total faculty strength (excluding faculty on medical/maternity leave) shall be allowed by their respective institutions to take study leave for pursuing Ph.D. degree.

The date and time of the interview will be communicated to the eligible candidates.
