

The Transparency mechanism of the WTO is fundamental for functioning of global trade agreements and also dictates the rules of conduct of the member countries. The speaker will highlight the operating of this mechanism and how the pandemic of COVID-19 has changed the ways of WTO in handling it. Due to the same pandemic, free trade agreements jump into focus as the situation calls for further lowering of trade barriers to facilitate non-discrimination principle. The speaker will also draw attention towards the International trade cooperation in the Asia-Pacific region as well as some of the major Global Trade Agreements.

Dr. Mia Mikic is a trade economist with a keen interest in sustainable development and with a proven track record and experience in academia and international civil service. She served Director, Trade, Investment and Innovation Division in as Nations ESCAP. She is currently an Adviser for and has United previously coordinated the Asia-Pacific Research and Training Network on Trade (ARTNeT), an open network of research and academic institutions and think-tanks in the Asia-Pacific region. Prior to her UN tenure, she was Head of the Department of Economic Theory, Professor of International Economics and Director of Economic and Business International Program at the University of Zagreb, and Senior Lecturer at the University of Auckland. She is the author of many books, reports, and papers and has edited or co-edited several volumes on international economics, regional integration, and development. She oversaw preparation of Asia-Pacific Trade and Investment Report (APTIR), a flagship publication in area of trade and investment. Her current research and advisory work focus on the impact of COVID-19 pandemic on trade and Global Value Chains, frontier technologies and inclusive future of work, advocating for women as influencers in policymaking, services trade, and promotion of evidence-based policymaking. She is collaborating with several universities on modernizing trade curricula. She has a Doctorate in Economics from the University of Zagreb.
